## Naloxone Provision over the Festive Period

Naloxone is a potentially life-saving medicine when used in opiate overdose. A focus on overdose awareness and Naloxone provision should be undertaken by services at this period of high risk.

Pharmacies currently participating in the Take Home Naloxone Programme should continue to supply, raise awareness of overdose risk and document these in the patient's Care Record in the PCR.

Additional counselling for these patients should be to check the patients or carers awareness

- Of signs and symptoms of suspected overdose e.g pinpoint pupils, breathing problems, blue lips, no response
- Of how and when to administer Naloxone
- Of the need to always call 999
- That Naloxone is short acting and effects will wear off after 20-30 minutes
- Of the importance of staying with the person until help arrives

\*\*\*Remember that Community Pharmacies can now hold emergency Naloxone\*\*\*

# Healthy Start

The Healthy Start Scheme was a programme which gave parents vouchers to help with the cost of milk, infant formula and certain foods along with access to vitamin drops for children and tablets for women. In August 2019 this scheme was replaced by the Best Start Scheme which covers the vouchers for milk and formula etc.

Healthy Start vitamins are no longer covered by this scheme and vouchers are no longer being issued. **The pharmacy distribution scheme has now ceased and participating pharmacies will no longer receive a payment for this.**

The vitamins will still be supplied in the following circumstances:

Pharmacies are requested to direct patients to their local distribution points to obtain supplies. If a patient wishes to purchase the Healthy Start vitamins, pharmacies are still able to obtain supplies from their usual wholesalers.
