### **Independent Prescriber (IP) Training**

Our latest training event took place on the 5th November with 21 in attendance. Dr Karyn Webster presented insightful training on paediatrics, ears and chests. Feedback was great and everyone found it hugely beneficial. The session then moved on to practical chest auscultation and case studies to allow for active discussions on prescribing and clinical decision making. This was also a good opportunity for IPs to develop networks and share experiences.

## **Injection Equipment Provision (IEP) Training**

Training for this service took place on the 31st October and 7th November. This training was very well received by the Community Pharmacies who provide this service in Forth Valley.

The main aim of injecting equipment provision (IEP) is to minimise the spread of blood borne viruses (BBV), such as HIV, Hepatitis B and C and other blood-borne diseases, which can occur as a consequence of injecting drug users sharing needles and syringes.

#### Flu & Covid Service

The Flu & Covid vaccinations are well under way and we have saw an increase in patients attending pharmacies, huge thank you to all pharmacies involved.

Smoking and Mental Health: Understanding the IMPACT

#### Our training is aimed at:

NHS, local authority and 3rd Sector staff and volunteers in the Forth Valley area who support people with mental health problems.

Equip workers who support people with lived experience of mental ill-health with the knowledge, skills and confidence to initiate a conversation about smoking, and to discuss options for supporting those who are ready to quit.
